1 Introduction

The Aboriginal Social and Emotional Wellbeing Plan (the Plan) is an initiative of Phase 3 of the Victorian Aboriginal Justice Agreement. The Department of Justice and Regulation has worked closely with the Koori community in Victoria to develop the Plan aimed at improving health and justice outcomes for Aboriginal and/or Torres Strait Islander people in prison.

The Plan identifies the fundamental role of culture, community and spirituality in Aboriginal health and wellbeing. Priority Area 1: Prevention and health promotion, and Priority Area 3: Culturally safe and responsive services aim to build the cultural safety and capacity of health services in responding to the needs of Aboriginal and Torres Strait Islander prisoners.

The *Health Service Provider Resource List* (the List) is intended to provide a comprehensive list of culturally appropriate resources for health service providers to access to inform and support service provision to Aboriginal and Torres Strait Islander prisoners while incarcerated and upon their release.

2 Document purpose

To inform health service providers of existing Aboriginal and Torres Strait Islander health resources and literature available in Victoria.

3 Scope

The List is primarily for the use of health service providers in the Victorian prisons. The health service providers will be responsible for updating, ordering and regular maintenance of the List as required. Any costs incurred will be the responsibility of the health service provider unless otherwise negotiated with Justice Health.

The List has been developed in consultation with the Plan's Health Reference Group, Corrections Victoria, Victorian Aboriginal Community Controlled Organisation, Victorian Aboriginal Child Care Agency and the Victorian Aboriginal Health Service.

5 Cultural Safety in Health Services

Creating an environment of cultural safety should be the core business for all health and mental health services engaging with Aboriginal and/or Torres Strait Islander people.

Cultural safety shifts focus from the individual practitioners to the health system in which they operate¹ facilitating a reciprocal environment for non-Aboriginal, Aboriginal and/or Torres Strait Islander people.

ACCOs are controlled by, and accountable to, Aboriginal and/or Torres Strait Islander people in those areas in which they operate. ACCO's aim to deliver holistic, comprehensive and culturally appropriate services and programs to the community.

The ACCOs provide an important link to local knowledge and resources for Aboriginal and/or Torres Strait Islander prisoners while incarcerated, and to strengthen partnerships with community organisations to ensure health and wellbeing are maintained upon release.
